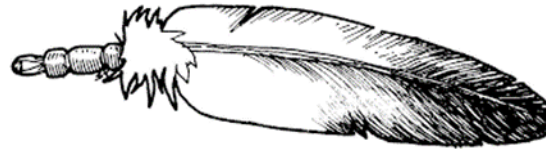
Traditional Dispute Resolution

This program applies to matters in the following areas:

- › Referrals for mediation by the Provincial Court of Alberta Family Division, Criminal Division, Youth Division, and Small Claims Court Division.
- › Disputes arising from personal, family, community relationships; the use or occupation of lands, housing, traditional land holdings.
- › Disputes arising from animal trespass, mischief regarding children, damage to private property, disturbances, theft, and nuisances.
- › Contracts entered into, where at least one of the parties are members of the Siksika Nation or Siksika Nation entities.
- › Siksika Nation Codes or By-Laws

Alternative Dispute Resolution

Attempts to resolve disagreements by stepping outside the traditional litigation process.



Mediation Model Aiipohtsiniimsta

Where two parties involved in a dispute are willing to come to the table to work out their issue(s) through the help of a Mediator and an Elder in an Aiipohtsiniimsta session.

Arbitration Model Aiskapimohkiiks

If Aiipohtsiniimsta does not work, The Aiskapimohkiiks Appeal Tribunal, which consists of a trained community member & an Elder can decide. A waiver signed by both parties gives consent to the Tribunal to make a decision that is final & binding.



Information on Aiipohtsiniimsta

In the Aiipohtsiniimsta session you will be making all the decisions. The Aiipohtsiniimsta facilitator has no decision-making power. The facilitator can make decisions if both parties consent and agree to what is being decided. Aiipohtsiniimsta is absolutely free and the amount of time the session will be is dependent on how agreeable the participants are.

Aiipohtsiniimsta's goal is to support your well-formed decision making. We will also make certain that the agreements are thorough and that each party is aware of the issues you may want to consider.

During the Aiipohtsiniimsta session, the facilitator and the elder will encourage both parties to work together to resolve problems and conflicts in a non-threatening environment.

Aiipohtsiniimsta would like both parties to experience their own abilities to resolve issues that they haven't been able to come to terms with.
