**GENERAL STATEMENT OF POSITION:**

The Family Enhancement Caseworker supports families in a culturally respectful manner to develop a range of healthy coping and problem-solving skills while under a voluntary Family Enhancement Agreement or Custody Agreement. Performs Family Enhancement and Custody Agreement services according to the Child, Youth and Family Enhancement Act (CYFEA) of Alberta. The Caseworker collaborates with service providers, family, and children in need as well as other significant persons involved. Uses the strength-based approach to practice.

**DUTIES & RESPONSIBILITIES:**

- Consults with Child Protection Team Lead on all activities, duties, and responsibilities.
- Works collaboratively regarding case transfer process from Intakes/Investigations Unit; and case transfer process to Temporary Assessment Caseworker or to On-going Assessment unit.
- All contact, activities, progress and relevant information on each child and/or family assigned is documented, accurate, and current.
- Clear knowledge of and ability to execute Signs of Safety (SOS) within field of practice.
- Assess factors of family (strength & weaknesses) potential risk factors of the family.
- Completes all financial responsibilities associated with assigned cases including recommended expenditures.
- Due to limited space, a full job description will be available to the successful interview candidates.

**QUALIFICATIONS/SKILLS:**

- Must have sound intervention skills (i.e. family dynamics, family interventions, crisis management).
- Diplomatic and professional, with excellent communication, negotiation and interpersonal skills.
- Possesses knowledge of aboriginal or Siksika culture, language fluency and history.
