They advise on corrective action and facilitate change to improve the health and safety culture. The OHS Supervisor is required to demonstrate a high level of professionalism and excellent interpersonal skills to be able to deal positively with all Nation Members, suppliers, consultants, contractors, and government officials.

- Investigates complaints related to health and safety. Interviews with supervisor's employees to obtain facts about work practices or accidents.
- Develop, implement and evaluate health and safety programs and strategy.
- Provide consultation and deliver training programs to employers, employees and the public on issues of public health, environmental protection, or workplace safety.
